Youth Safety Training Guide

Introduction

Effective youth safety risk management requires attention to all three organisational elements – our culture, our people and the environment

The focus of people risk management action is to ensure all adults who interact with young people under the age of 18:

- have been assessed suitable to do so;
- understand the importance of youth safety;
- are aware of the Defence Youth Safety Framework (DYSF);
- · are trained to minimise any risk of abuse or neglect; and
- agree to undertake their duties in accordance with the Code of Conduct.

The Defence Youth Safety Training continuum provides a tiered approach to youth safety training appropriate to role and responsibilities. The continuum comprises six levels including a youth package designed for young people between the ages of 12 and 18 years. The continuum is being developed over time. The proposed release dates for Levels 2 through 6 are included in the table below.

Implementation

ADF Cadets

Completion of the Safeguarding Children Awareness Package (SCAP) was a pre-requisite for acceptance for all Officers and Instructors of Cadets and a requirement for adult volunteers to work without supervision. SCAP has been replaced by the Level 1 Awareness and Level 2 Practitioner training packages with effect 31 March 2017.

From 31 March 2017 all ADF Cadet Officers, Instructors, Defence Approved Helpers and ADF Cadets Adult volunteers will be required to complete Level 1 and Level 2. Cadets aged 18 and over do not need to complete Level 2 Practitioner. Instead, this cohort will complete the Level 6 Young Adult (18-25) package.

Defence

Effective 31 March 17 all Defence personnel and contractors whose roles involve interaction with young people under the age of 18, must complete:

- Level 1 Awareness training before commencing in the role; and
- role-specific training as defined by the Defence Youth Safety training continuum no later than 30 days after commencing duties in the role.

Defence personnel and contractors whose role involves regular interaction with young people under the age of 18, particularly those who have direct contact and/or supervise overnight stays are to complete the Level 1 Awareness training (if not previously completed) and Level 2 Practitioner training no later than 30 June 2017.

Youth Safety Training Overview
